Objective: To test redundant forms of communication while

distributing PPE to multiple coalition partners

Description of Event: The HPP COVID cache needed to be distributed to healthcare partners throughout the regions. To do so, tiers were developed for equitable distribution of materials, and emails were sent to the respective agencies. Agencies completed a survey to indicate PPE needs then orders were filled and shipped out.

Summary of Event: Emails were sent to two tiers of healthcare contacts in each region to fulfill PPE needs from the HPP COVID cache. Emails were sent to the contacts for the following healthcare facility types, Tier 1 – RHCs, FQHCs, LTC, and Dialysis Centers; Tier 2 – Home Health, Hospice, EMS, and Ambulatory Surgery Centers. Facilities were asked to complete a survey of PPE needs then orders were filled and shipped out.

Announcement: (Example below from Tier 1, Tier 2 was similar)

The Department of Public Health and Human Services (DPHHS) Healthcare Preparedness Program (HPP) has secured a cache of Personal Protective Equipment (PPE) utilizing COVID-19 pandemic funding that we would like to distribute to our healthcare partners throughout the state. As facilities continue to grapple with ongoing surges of COVID patients and prepare for potential influenza or other outbreaks, this PPE will help ensure that facilities are adequately prepared to provide patient care.

In an effort to further our engagement and relationships with all provider types within each region, a tiered approach has been developed to distribute this PPE. The first tier of outreach consists of Dialysis Centers, Long-Term Care Facilities, Rural Health Clinics and Federally Qualified Health Centers. If materials remain available after outreach to the first tier, Tiers 2 and 3 will be contacted.



We are aware that the person receiving this message may be the point of contact for partner agencies throughout the region or state. We ask that you consult with your partners on their needs prior to completing your request. All PPE is medical grade and will be able to integrate into your supply rotation.
